

## RULES AND REGULATIONS

OPEN TO ALL ACTIVE Region 1A MEMBERS, RETIREES AND LOCAL 600 LEAGUE MEMBERS  
(A MINIMUM OF TWO MEMBERS FROM ABOVE LIST PER TEAM) WITH Family & Friends  
SPECIAL CONSIDERATION WILL BE GIVEN TO LOCAL 600 BOWLERS

- 1 A team entry cap of 1100 will be used (teams over 1100 team average will not be allowed to participate)
- 1A. The highest yearbook average 2014-2015,2015-2016,2016-2017 Seasons (21 games or more) will be taken  
No summer League averages
- 1B. Any Bowler carrying a Sport Bowling average, will comply with USBC rule 205. Average Adjustment
- 2 In case of no qualifying average(see rule 1A), highest current league average 2017-2018 ( 12 games or more) will be taken. Bring verification of current average from league secretary.
- 3 If current 2017-2118 league average (21 games or more) is ten pins above highest yearbook average(rule 1A) then Current average must be used(bring verification of current average from league secretary).
- 3A. The Tournament Director reserves the right to re-rate averages that are questionable prior to bowling.
- 4 Bowler failing to meet any of the above requirements can enter with a scratch average of 180 for men and 165 for women.
- 5 USBC and Non-USBC members may participate but with high score recognition only to USBC members, as this Tournament is covered with a moral support sanction Rule 302a. Eligible non-league bowlers can qualify for High score recognition by paying a \$21.00 USBC fee and an affiliate card will be issued by the USBC.
- 6 Multiple entries allowed but no more than three bowlers on same team may place more than once in a prize list.
- 7 Bowlers are cautioned to familiarize themselves with the new re-rating requirements of USBC Rules 319 & 319E Which applies to all tournament participants.
- 7A. Rule 319d – Any entrant who has won a prize of \$600.00 or more in any event of a tournament during the 12 month period, to enter in this tournament must report actual score, position and amount won to the tournament manager.
- 8 All winners must produce absolute proof of their averages before receiving prizes.
- 9 False averages given---team forfeits right to prize, subject to review of Tournament Committee.  
Claims for errors in scoring must be made within 24 hours after bowling.
- 10 Alleys will be assigned. Teams will remain on alleys assigned for all three games.
- 11 Bowlers are requested to check in or make necessary changes at least one-half hour before starting time.
- 11A. Average corrections to be made up to completion of the first games of a series. See rule USBC 319A-4.
- 12 Teams must bowl in the order their names appear on the entry blank.
- 13 Preferred time will be granted whenever possible, however , the Committee reserves the right to schedule According to alleys available.
- 14 NO ENTRY MONEY WILL BE RETURNED AFTER BEING RECEIVED AND ACCEPTED.
- 15 In case of NO SHOWS, said team will forfeit entry fees and rights to prize money. Late bowlers will not be Allowed to make up frames.
- 16 In case of a tie for 1<sup>st</sup> place, the teams involved will bowl a 3 game roll off. Total pins plus handicap will determine winner.
- 17 ENTRY DEADLINE- SATURDAY JANUARY 20, 2018, 5:00P.M.
- 18 CARRY THIS STATEMENT WITH ENTERING AVERAGE RULE. It shall be each bowlers responsibility to verify The accuracy of his/hers average, whether originally submitted by the bowler, his/her team captain or others. Failure to use proper average or make a correction prior to or at the time of bowling shall disqualify score If submitted average is lower than actual average.
- 19 PROTEST RULE-329 Protest involving eligibility or playing rules must be made to tournament management in writing within the time limits of rule 329. The decision of tournament management will be final unless a written appeal is filed with USBC Headquarters within the time limits of rule 329.
