

TOURNAMENT RULES

AVERAGE RULES

Read Carefully

1. Participants must be members of USBC. Non members must purchase a card prior to bowling. Cost is \$25.00.
2. This tournament is open to all amateur men and women bowlers.
3. The Tournament Directors reserves the right to reject any entry or adjust any bowler's average before scheduled bowling. Tournament Director will have the right to change lane assignments if there is a mechanical failure which resulted in a 10 min minute wait or more.
4. Any bowler who has been rerated, adjusted or refused a re-rate by USBC must list this information on the entry or be disqualified.
5. Prize fee will be return at 100% of Prize Fund. At least one prize for each ten entries.
6. After the initial entry is paid, a bowler may enter with an additional partners by paying an additional \$20.00 fee per bowler.
7. Bowlers may cash with multiple partners but only once with the same partner.
8. PBA or LPBA members fi from 2015 to present are ineligible to bowl.
9. There will be no refunds for no-shows.

Apply to All Participants

1. Highest USBC book averag for 2017/2018 season 21 games minimum will be used to determine handicap.
2. If a bowler does not have a yearbook average for the last 3 years, he/she must provide verification for this season. (21 games minimum) If bowler cannot provide verification of average, must bowl from a 220 scratch.
3. Individual handicap will be 80% of 220. Team Cap is 440.
4. If at the time of bowling an entrant has a current average for 21 or more games that is 10 pins or more higher than the prior season average, the current average must be used.
5. Failure to use the adjusted average is cause for forfeiture of entry fees and prize winnings.
6. Tournament is govern by USBC rules unless otherwise stated.
7. Maximum score bowled with handicap is 300 for all jackpots.
8. Payoff will ll be made after verification of averages.
