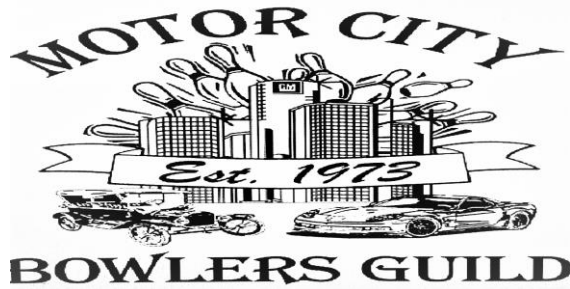

MOTOR CITY BOWLERS GUILD SPRING FLING MIXED DOUBLES HANDICAP TOURNAMENT RULES

1. This tournament is open to all USBC certified bowlers.
2. This tournament will be bowled in accordance with rules adopted by USBC.
3. Bowlers may bowl both squads, cash only once with the same partner in the Mixed Doubles Event. Cash only once in the Singles Event.
4. **AVERAGE REQUIREMENTS: SUMMER AVERAGES WILL NOT BE ALLOWED.**
 - a. Bowlers must use the highest USBC Certified league average of not less than 21 games of prior season (2017-2018).
 - b. Bowlers with no average must bowl with a 220 average.
 - c. If as of 03-30-19 a bowler has a current average for 21 games or more that is 10 pins higher than the prior season's average, then the higher average must be used. (USBC Rule 319 A-2)
 - d. USBC Rule #319A-3 will apply to all participants of this tournament.
5. It shall be each bowler's responsibility to verify the accuracy of his or her average. In Accordance with USBC Rule 319A-3, whether originally submitted by the bowler, the team, or others. Failure to use the correct average shall disqualify the score if submitted average is lower than correct average, thereby resulting in a lower classification or more handicap. You will have until the end of your 1st game to verify the correct average. If after that said time if the average is found to be incorrect the score shall be disqualified. Prize winning shall be based on the submitted average if it is higher than the correct average. Tournament Director has the right to re-rate any bowler.
6. Check in begins 60 minutes prior to squad time.
7. Handicap will be 80% of 220 on an individual basis for singles and 80% combined for mixed doubles. Touring Pros or PBA card holders are not eligible.
8. Prize fee will be returned 100% in each event which it is collected. There will be at least 1/8 ratio in Mixed Doubles and the Singles Event. 2 Divisions Men and Women.
9. In the event of mechanical failure, it is hereby agreed that the bowlers affected shall be moved to the next available lanes in the establishment at the discretion of the Tournament Director.
10. No entry application will be accepted unless accompanied by entry fees. No entry fees will be returned once scheduled.
11. Premature termination of the tournament brought out by war, national emergency or emergency causes relating thereto or there from; fires, strikes, lockouts, weather, labor difficulties or other reasons beyond the control of the Bowling Center shall cause the foregoing prize schedule to be prorated in accordance with the number of entrants who have bowled.
12. All decisions made by the Tournament Director are final.
13. **USBC RULES WILL APPLY TO ALL OTHER RULES NOT COVERED ABOVE.**
